Report from Devon County Councillor County Cllr Graham Bell's report was circulated prior to the meeting.

The County Cllr explained that he had been approached by the Dementia Association for North Devon as they are looking for somewhere to store their dementia bike. He had suggested they approach Barnstaple Railway Station and Fremington Quay.

The County Council had now cut back the basal growth at the base of the Lime trees along the A361. The Lime trees are being assessed for further works which are hoped to be carried out by the end of October.

Cllr E Spear requested if there was any update regarding the missing staggered sign at Corilhead and Corffe Green. The County Cllr would chase this matter up.

Cllr L Childs had been approached by a concerned resident regarding pedestrians crossing at The Square traffic lights. Many motorists jump red lights at this crossing and put pedestrians in danger. It was suggested that perhaps cameras would discourage motorists from jumping red lights. It was also suggested that a yellow box would improve the safety at this junction. The pedestrian crossing on Exeter Road does not operate in conjunction with The Square traffic lights. If this was improved it may also help prevent motorists getting stuck in the middle of the junction.

The County Cllr reported that BT had now started to raise the sunken drains on the A361 between Ashford and Braunton.

Cllr R Byrom requested when the Caen Street gully drain would be repaired properly. The temporary repair to infill the hole with rubble is causing an obstruction in the drain and surface rain water is unable to drain away. If the drain is not properly repairs it will cause flooding in Caen Street during the autumn and winter months.

Cllr R Shapland and Cllr M Shapland thanked the County Cllr for the drainage works carried out in Church Street.

Report from North Devon District Councillors

The Chairman noted District Cllr Pru Maskell's apologies due to being unwell.

District Cllr Graham Bell's report was circulated prior to the meeting.

District Cllr Liz Spear reported that although only a month

had passed, there are major events that will impact on not only Braunton but the whole of North Devon. Firstly, the suggested merger plan for Petroc College and Exeter College - this is a hugely positive opportunity for the whole of North Devon community. particularly, for the coming younger generation. There will be a public consultation that is running until 30 September.

The Government's reorganisation of local government plan would abolish the three layers of local councils. It does not abolish Town and Parish Councils but It will mean that we would lose North Devon Council. Devon County Council will also disappear. For each new Council, the Government wishes to have at least a population of 300,000 – the likelihood for North Devon is that we would be "left out" and isolated – Tony Blair called it Rural Proofing. Like or loathe our District Council, it is relatively easy to contact.

The last change in the Local Government structures was that Devon County Council lost both Plymouth and Torbay. That was 1993 and the County came out very badly when the assets and liabilities were finally agreed upon and we in North Devon became part of the price!

Devon Councils currently owe a total of £1.9bn. This is the tip of an iceberg! Local Government has been slowly starved of adequate funding for many years without a fully guaranteed funding plan for any future changes – do we really believe that would happen anyway?

The District Council is currently concerned about the Government plans. Regardless of Party and what is said and being done, the debates have been around how we can protect the wellbeing of our communities. All over Devon there is no real agreement how the Government plans will be decided – there are only potential parameters. The suggestion at the moment from the District is technically possible, and of course there appears to be a fallback position – purely my view but I regret that the Torridge Leader has turned down the idea of a joint authority.

Petroc College also serves both North Devon and Torridge as well as others and the proposals for merger with Exeter will bring in skills and funding.

Cllr G Bell left the meeting at 7.44 pm.

The Clerk reported that the temporary pothole repairs on Bridleway 52 had deteriorated over the summer. Devon County Council, the Highway Agency and landowner are responsible for maintaining the surface of bridleways. There appears to be no registered owner of Bias Lane and the County Council have confirmed that it has no intentions to repair the potholes as they can be navigated around safely and easily by walkers, cyclists and horse riders. The County would have no objections to the Parish Council resurfacing the affected areas of Bridleway 52, providing a similar surfacing was used.

136/2025/26 Flowbird App Parish Council Car Park

The Clerk reported that in January Flowbird was acquired by the EasyPark Group. In the past few weeks, the two companies have merged under the corporate umbrella Arrive, a global leader in parking, mobility and transport solutions.

From October 2025 the Flowbird app will no longer be operational in the UK. One of the Arrive brands is RingGo but they are unable to offer the Parish Council its own account as the setup cost would not be financially beneficial, also lead-time to create a new account would be 8-10 weeks. Options going forward are to:

- Create RingGo zones for the Parish Council's car parks under an existing RingGo account.
- RingGo have a number of partners who may take on a side contract.
- Cease App operations altogether

North Devon Council (NDC) are considering providing zones for the Parish Council under its existing RingGo account. This would be subject to confirmation from their Legal dept. regarding NDC having access to the Parish Council's financial data.

Members expressed their disappointment that this merger of corporate companies had resulting in the Parish Council being left without a car park payment app. In most situations when companies merge the affected clients are automatically transferred over to the new service provider.
