094/2025/26 **Action Sheet**

Cllr A Bryant reported that he had walked part of the proposed Tarka Trail extension between Knowle and Foxhunters with the North Devon MP. He explained that the works to extend the Tarka Trail had continually been delayed by the County Council. John Grimshaw of Greenways and Cycleroutes approached Devon County Council to offer his expertise but DCC had been reluctant to engage with him. The ND MP had agreed to contact DCC on their behalf.

The bridleway running from the Nethercott Road towards Heddon Mill has a brand new strip of tarmac. Cllr A Bryant requested why the footpath that continues on from the newly surfaced bridleway could not be utilised instead of building an expensive bridge over the River Caen and a series of embankments. He further commented that there had been little communication between DCC and the parishes affected by this project.

The Chairman advised that Cllr A Bryant emails our County Cllr Graham Bell with his concerns. Cllr Bell explained that the section between Heddon Mill and Spreacombe is progressing well. He assured members that the County officers are actively working on all parts of the project. He has been in discussions with Cllr A Bryant regarding this matter and advised that he is doing all he can to progress the works.

District Cllr Liz Spear had provided the Clerk with an update from Cllr Malcolm Wilkinson regarding the Tarka Trail extension, she requested that this be circulated to all members for their information.

The Council congratulated the Clerk for the work she had done to open the Pavilion public conveniences at such short notice.

The Chairman welcomed Curtis Netherway from the Braunton Football Club.

Curtis thanked the Council for its support with the Club's planning application to extend its car parking at Lobb Field. There had been some delays with the planning department the Club were required to provide a Biodiversity Net Gain Report which the Parish Council kindly funded. The Local Planning Authority have also insisted on consulting Sports England even though the Club confirmed that the additional parking would not encroach on existing pitches. Funding for the project had now been secured from Section 106 money and Fullabrook.

There are four pitches at Lobb Field the Club has a membership of 400 children and are struggling to accommodate all matches on the existing pitches at Lobb. The Club would like to start using the pitch on the Recreational Ground for the under 13's girls' team. The pitch size will be smaller than the adult pitch and they would need to purchase new smaller goalposts that would be easier for the youth teams to carry and install.

They will need to use the Recreational Ground at least every fortnight during the season but friendly games may increase use to every weekend on a Sunday and the occasional Saturday. Curtis commented that the facilities at the Pavilion are great and modern and much better than they have been used to when hiring the Astroturf at Braunton Academy. He requested if the Council might be able to cut the pitch area weekly, he understood that the Recreation Ground is cut every 2-3 weeks. If the Council's are unable to cut the pitch area weekly the Club will have to see if its groundman at Lobb would be able to cut it. He requested if the Council would be able to provide a ride on mower for them to use. The Club will arrange lining of the field prior to all games.

Dog faeces left on the pitch is a concern the Club have responded to the Council's consultation requesting that dogs are banned from the Recreational Ground.

Members agreed that it would be great to see the Recreational Ground pitch being used again at weekends for football.

Cultural Music Event in Braunton 2026 The Chairman welcomed Helen Cooper to the meeting.

Helen explained that she was working with local venues to provide a music event next May call 'Braunton Beats'. The idea came from attending the Appledore Cultural Festival the organisers of this event had been very helpful sharing information, documents etc. It was agreed that the 15, 16 and 17 May 2026 would be the best dates as it wouldn't conflict with other events happening in the local vicinity. The idea is to pepper the village with different experiences and genres of music providing a variety for people to enjoy.

Braunton Beats is a not for profit organisation they aim to start the event small and hope that it grows. They have started to engage local venues, businesses and organisations for funding and their support.

The Council is fully supportive of this event it will be good for the local businesses, residents and visitors to the area. Its parish grants for 2026/27 would soon be open for applications.

The Chairman thanked Helen Cooper for updating members regarding Braunton Beats.

The Chairman welcomed Mark Johnson from 1st Chivenor Scout Group. Mark explained that the 1st Chivenor Scout Group was established 18 years ago to include females in the scouting community. At present they pay rent to hire meeting space at Southmead School their outdoor equipment is stored elsewhere in a units behind Tesco. They have been given notice on this storage space and are looking for a temporary site (approx. 2 years) to place a porta cabin to store their equipment. They would need access approx. once a month and proposed that the Recreational Ground in Braunton maybe a suitable site.

The Clerk advised that a porta cabin on the Recreational Ground would require planning permission. It would need to be sited as to not obstruct access to the football storage adjacent to the Pavilion and to allow space for a tractor and flail to carry out routine maintenance to the boundary hedgerows. They may also have difficulty obtaining planning permission as it would be contrary to Policy BE6 in the Braunton Neighbourhood Plan. The Clerk proposed that Stoney Bridge Depot might be a more suitable site. The 1st Chivenor Scout Group had considered but ruled it out due to the difficulties that the Mens Shed had with obtaining planning permission. It

was noted that this would be a different use that would require less access to the Depot than the Mens Shed required.

Mark Johnson had approached the Chivenor Base but had not received a response and Heanton Punchardon Parish Council had referred him to Braunton Parish Council, hence his request. They have also looked into self storage at Chivenor Cross but rent would be £2,400 per annum a third of their annual income. They have already increased their fees by 20% charging £60 per term and don't want to increase them further and price out families from being able to attend the group.

The Council agreed that the Stoney Bridge Depot would be a more appropriate site to place a porta cabin for storage. The Clerk advised a suitable location but it would need clearing first. The Council would also be interested in buying the porta cabin if it was no longer needed for storage by the 1st Chivenor Scout Group. The Clerk explained that the site is classed as 'Sui Generis' and would probably require planning permission to site a porta cabin.

RESOLVED: That the Council agrees that the 1st Chivenor Scout Group can place a porta cabin at the Stoney Bridge Depot subject to them obtaining planning permission.

D-Day Commemorative Event 2026

The Chairman welcomed Chris Horrell to the meeting.

Chris introduced himself, he is Barnstaple Town Councillor but today he is attending as member of the public who would like to provide a D-Day Commemorative Event in Braunton next year. He has experience providing events of this nature he organised a VE Exhibition in the Barnstaple Pannier Market. He produced a World War 2 video with projection and sound which was very well received being fully booked for all showings. The event involved a significant number of school children and hopes to involve the local schools with his event in Braunton.

D-Day has always been commemorated at Saunton Beach up until recent years. It involved planes landing and remembered how important this local area was to war efforts in WW2. Unfortunately due to limited parking, health and safety and other restrictions the Saunton Beach D-Day event can no longer happen. Chris proposed bringing the D-Day event back to Braunton by utilising the Recreational Ground. This is a brilliant site in a central location and would allow everyone to safely attend the event. The event would include a black marquee showing a video about Braunton in WW2 and

featuring the importance of the Braunton Railway. Laying of wreaths, reenactments and a Parade. They would visit local schools prior to the event to engage the children. Dates proposed are 5, 6 and 7 June 2026.

The Council were fully supportive of this event and welcomed the D-Day Commemorative Event being held in Braunton again showcasing Braunton's history during the war efforts.

- The proposed development is adjacent to the National Landscape the noise and light pollution from the development would have a negative impact on the Caen Valley Bats SSSI and Parish Bat Population. It would therefore be contrary to polices NE3 and BE13 in the Braunton Neighbourhood Plan (BNP).
- The development would not be in keeping with the area being in close proximity to Grade II Listed farmhouse and the National Landscape. It would have an adverse impact on the character and heritage assets and their settings, contrary to Policy BE2(ii) in the BNP.
- Concerns regarding safe vehicular access and egress the road leading to the site is not adequate to cope with the increased number of vehicles that this development will create.

The Chairman confirmed that she is in discussions with the Practice Manager at Caen Medical Centre and has expressed the Council's support for a Pharmacy to remain in Braunton.

Cllr G Bell explained that Devon County Council would be carrying out a Pharmaceutical Needs Assessment (PHA) and that it would not be consulting the community. The PNA will address pharmacy requirements across all communities. He clarified that is not just government funding that is the issue but there is also a shortage of qualified pharmacists.
